

# City of Stevens Point Canvassing Board Minutes

**April 8, 2024 - 8:00 AM**  
**City Hall, 1515 Strongs Avenue - City Conference Room**

- 1. Canvass the municipal results for all even-numbered District Alderpersons and any provisional ballots for the April 2, 2024 Presidential Preference and Spring Election and correct any errors or irregularities as a result of such canvass.**

The committee verified the number of provisional ballots for each district. District 1 - had one provisional ballot that was not rectified by voter. District 2 - had zero provisional ballots. District 3 - had zero provisional ballots. District 4 - had zero provisional ballots. District 5 - had zero provisional ballots. District 6 - had zero provisional ballots. District 7 - had zero provisional ballots. District 8 - had one provisional ballot that was not rectified by voter. District 9 - had one provisional ballot with one voter having rectified. District 10 - had zero provisional ballots. District 11 - had zero provisional ballots.

The committee reviewed the documents for the provisional voter. Clerk Yenter opened the ballot bag number 0841661 and the provisional ballot envelopes. The committee processed the provisional ballot, agreed the tallies were correct, and adjusted the tape to reflect the vote accordingly. The committee sealed the ballot in ballot bag number 0841444 and updated the Inspector's Statement. The Board of Canvass members signed the ballot bag and paperwork for processing the provisional ballot. The committee assigned voter number 373 to the provisional voter.

In District 2, after review of the materials, the committee verified there were a total of 514 votes for Alderperson. The committee determined the results to be as follows for District 2: Jacqui Guthrie received 301 votes, Craig R. Tesch received 182 votes, 1 scattering, 30 Under Votes. In District 2, Wards 4 & 5, after review of the materials, the committee determined the results to be as follows for Alderperson: Jacqui Guthrie received 233 votes, Craig R. Tesch received 141 votes. In District 2, Ward 6, after review of the materials, the committee determined the results to be as follows for Alderperson: Jacqui Guthrie received 68 votes, Craig R. Tesch received 41 votes.

In District 4, after review of the materials, the committee verified there were a total of 450 votes for Alderperson. The committee determined the results to be as follows for District 4: Lara Broderick received 335 votes, 10 scattering, 105 Under Votes. In District 4, Wards 10 & 11, after review of the materials, the committee determined the results to be as follows for Alderperson: Lara Broderick received 213 votes. In District 4, Ward 12, after review of the materials, the committee determined the results to be as follows for Alderperson: Lara Broderick received 122 votes.

In District 6, after review of the materials, the committee verified there were a total of 852 votes for Alderperson. The committee determined the results to be as follows for District 6: Jason Behrendt received 298 votes, Dale Steinmetz received 490 votes, 2 scattering, 62 Under Votes.

In District 8, after review of the materials, the committee verified there were a total of 801 votes for Alderperson. The committee determined the results to be as follows for District 8: Dean Shuda received 499 votes, Chris Donohoo received 249 votes, 3 scattering, 50 Under Votes.

In District 10, after initial review of the materials, the committee verified there were a total of 542 votes for Alderperson. The committee determined the results to be as follows for District 10: Dustin Buse received 297 votes, Bob Larson received 200 votes, 2 scattering, 41 Under Votes. In District 10, Ward 28, the committee determined the results to be as follows for Alderperson: Dustin Buse received 151 votes, Bob Larson received 122 votes. In District 10, Ward 29, the committee determined the results to be as follows for Alderperson: Dustin Buse received 21 votes, Bob Larson received 30 votes. After further review of District 10, Ward 30, the committee determined the results to be as follows for Alderperson: Dustin Buse received 125 votes, Bob Larson received 48 votes.
