- 1. Canvass the municipal results for City Clerk, City Comptroller/Treasurer, City Attorney, and odd-numbered Aldermanic Districts and correct any errors or irregularities as a result of such canvass.**

The committee verified the number of provisional ballots for each district was zero.

The committee verified that the certification page on all poll books were completed.

The committee verified that Inspectors' Statements were complete, verified the voter number and number of ballots matched, and verified that any anomalies were explained and documented within the Inspectors' Statement.

In District #1, after review of the materials, the committee determined the results to be as follows for City Clerk: Aline Cychosz received 201 votes, Susan Pagel received 645 votes.
